SLMA Skin Bar FlexPay Rules & Regulations

Effective June 2025

Eligibility & Usage

- FlexPay may be used for the purchase of SLMA Skin Bar services only, including facials, injectables, laser treatments, microneedling, massage, body treatments, and service packages (such as Beauty Flights and treatment bundles).
- FlexPay **cannot** be used to purchase retail products, memberships, or gift cards.
- FlexPay is not valid for any prepaid/store credit packages, bonus cards, or promotional cards that function as cash equivalents.

Payment Methods

- All FlexPay balances must be paid using a valid credit or debit card registered to your account.
- Payments **cannot** be made using cash, checks, bonus cards, promotional cards, or gift cards.
- Accepted cards: Mastercard, Visa, American Express.

Plan Structure

- A 25% down payment is required at the time of service, paid via credit or debit card.
- The remaining balance is paid in monthly installments according to your selected FlexPay plan (3, 6, or 12 months, or special payment plans when available).
- The financed amount (total minus down payment) is set up in Paythen for automatic monthly payments.

Promotions & Discounts

- FlexPay **cannot** be combined with other discounts, specials, or promotional offers unless specifically stated by SLMA Skin Bar.
- Special FlexPay plans are only available for full-priced services and **cannot** be used in conjunction with sales, specials, or other promotions, unless specified.

Bonus/Promotional Cards

- Bonus cards, promotional cards, or any other cards or certificates that are not the same as cash **cannot** be used to pay any portion of your FlexPay balance.

Payment Authorization

- By enrolling in FlexPay, you authorize SLMA Skin Bar and its payment processor to automatically charge your registered credit or debit card for the agreed-upon installment amounts per your plan schedule.

Late or Missed Payments

- Late or missed payments may result in a late fee as outlined in your payment agreement.
- Repeated missed payments may result in suspension of FlexPay privileges and/or cancellation of services.

Early Repayment

- You may pay off your FlexPay balance early at any time without penalty.

Refunds & Cancellations

- Refunds for services purchased through FlexPay will follow SLMA Skin Bar's standard refund policy.
- Any refund issued will first be applied to any outstanding FlexPay balance.
